The items that were discussed at this meeting were as follows:

- 1. Joe Holoubek, introduced himself, Mike Davis of the AACO FMD, Randal Daugherty, DFI, and Michael Schillenberg of RMF.
- 2. Bids are due Tuesday, March 12, 2024 by 1:30 PM local time. Bids are to be submitted electronically through the County's PORT system. Bids will be opened and read publicly via ZOOM.com. All are welcome to join the bid opening using the ZOOM credentials provided in the Notice to Contractors provided in the solicitation.
- 3. Bidders must use Anne Arundel County forms and proposals as included in the Project Manual and must not alter the language.
- 4. The project has requirements for bid bond, material and labor bond, performance bond, and maintenance bond. If a maintenance bond is not provided, Anne Arundel County will retain 5 percent of the contract amount for one year.
- 5. The project construction is located in the Heritage Office Complex at 2660, 2662, 2664, 2666 Riva Road, Annapolis MD 21401.
- 6. The Work includes the following major items: The Work includes Replace the existing roof top units.
- 7. Contract period is 270 calendar days, with liquidated damages of \$500.00.
- 8. Notice to proceed will be given to the selected contractor in Jul-Aug 2024. Bids should reflect that time period.
- 9. Project must comply with all Contract Documents including Anne Arundel County Standard Specifications and Details, available at <u>www.aacounty.org</u>.
- 10. Period for payment by Anne Arundel County will normally be thirty (30) days from receipt of invoice.

- 11. Prevailing Wage and Local Hiring will be required on this Project.
- 12. The award of the project will be based on the lowest total bid.
- 13. Smoking is not permitted in the building.
- 14. Bidders should visit the site to become familiar with existing conditions relevant to the project.
- 15. The contractor, indoors or outdoors, must restore damage to any area. Anne Arundel County will be taking photographs prior to construction to document existing conditions.
- 16. Contractor must call for all inspections. Contractor is responsible for obtaining required trade permits.
- 17. The County will have an on-site inspector, DFI.
- 18. All work that requires a long term (more then one hour) shut down of the units will need to be on weekends or off hours. When removing the units, the units most be operational on next business day. For example, you will be able to start setting up cranes and disconnecting units a 5PM on Friday and unit must be operational Monday morning at 6AM.
- 19. All questions should be submitted in writing to Michael Schillenberg of RMF and carbon copies to Joe Holoubek. Questions will be accepted until March 4 at 12:00 PM. As deemed appropriate, responses will be provided in an addendum or a clarification.
- 20. Site visits was conducted after the meeting.
